- 9. Learning outcomes of the course unit: As a result of the course postgraduates should acquire:
- **Theoretical knowledge** related to: the technology and methodology for developing and implementing European strategies and policy areas; the priority areas of EU policies and the strategies leading to the development of the European Union and especially for the new programming period 2014-2020
- Specific **practical skills**: to use their theoretical knowledge of EU strategies and policy areas in developing and implementing national sectoral, regional and municipal strategies and plans and to know how to connect common European strategies and policies with the national ones; to elaborate the main elements of a project proposal in the context of European strategies and policy areas and to link funding of projects with the current annual and perennial priorities of the strategic documents and programs.

The main aspects of European policies, the programs and funds that finance their implementation. Legislative and institutional basis for the implementation of European policies. Structure of the European Commission, Executive Agencies and Departments dealing directly with the implementation of strategies and policies. Structure and administration of the programs for implementation of European strategies and policy areas in Bulgaria. Presentation of web resources for the policies and strategies.

Planned learning activities and teaching methods: lectures with prepared attractive presentations, performance and display of Internet resources in real time, postgraduates' involvement during lectures with a pre-set assignment, discussions and debates.
