Learning outcomes of the course unit: The objective of the course in Social Security Law is students to acquire the needed theoretical knowledge in the area of Social Security Law and Law of Social Assistance, which will give them the opportunity to individually resolve insurance problems arising in social practice. A very important learning outcome of their training in this course is the formation of skills for individual research work in the field of Social Security Law and the right to social assistance.
