Evidence is supported clearly, precisely and convincingly, quoting the relevant regulatory acts. The final part expresses the student' clear statement on the question by using precise literary terminology and linguistic competence. **VERY GOOD:** The student has complete and thorough knowledge, has practical skills, possesses logical and thorough thought, uses legal terminology skillfully. Most of the information is skillfully developed. Evidence is supported clearly, precisely and convincingly, quoting the relevant regulatory acts. There is a slight imbalance

in the presentation of the main arguments. The final part expresses the student' clear statement on the question by using precise literary terminology. Some language errors are allowed. **GOOD:** The student has complete knowledge, practical skills, possesses thorough thought, uses legal terminology skillfully. The prevailing part is description rather than analytical thinking. The answer contains basic information, but with a slight imbalance in its presentation. Evidence is supported clearly, precisely and convincingly, there is quotation. Student's opinion is clarified in the final part. Some language errors are allowed. **SATISFACTORY:** The student answers the essence of questions with some difficulties, has insufficient practical skills and abilities and does not usually express his thought correctly. Evidence is presented in understandable but not in correctly structured way. Some of the arguments are misunderstood, but the overall the point is clear. There is an attempt to form a conclusion, but the student's position remains unclear. There are omissions and inaccuracies in the language. **POOR:** The student does not have the necessary knowledge, makes factual mistakes, has difficulties in answering, does not know how to explain the nature of the question. Insufficient amount of information. The presentation of information lacks a good argument. The quotation is incorrect. There are serious errors.
