- 9. Learning outcomes of the course unit: students acquire knowledge in the field of psychology and in one of its sections legal psychology, with the latest settings in theory and practice. The lecture course presents the nature and specifics of legal psychology. Students acquire psychological knowledge of fighting crime in three main areas learning the nature and characteristics of criminal behavior and criminal realization of the individual, organization of work in identifying, investigating and prosecuting offenders, organizing preventive activities and the activities of penitentiary institutions.
