- 9. Learning outcomes of the course unit: Acquiring knowledge about organized crime its appearance, development and nature in different countries and regions; international criminal organizations their activities in the conditions of globalization; money laundering and corruption.
  - 10. Mode of delivery: face-to-face
- 11. Prerequisites and co-requisites: Learning the material requires that students have prior knowledge as a result of completing the courses in Criminal Law general and specialized part, Criminology general part, as well as Criminology types of crime, etc.
- 12. Course contents: The course meets the increased scientific and practical need for clarification of one of the most topical problems of modern society, that is, high criminalization, a change in the nature of crime and globalization of transnational organized crime. It aims at broadening students' academic knowledge about the problems of organized crime, money laundering and corruption, and preparing them for adequate participation in implementing government policy on the prevention and control of organized crime. Emphasis is placed on: 1) The nature of organized crime and its transnationality emergence of organized crime, regional differences and general characteristics. It is considered in the light of the theory of an enterprise, the links between organized crime and conventional, economic and corporate crime, including the ongoing convergence; 2) The nature of corruption history, types of corruption, regional differences, the relationship between corruption and organized crime corruption in public administration, private sector, including political corruption, 3) The modern state policy to combat organized crime and corruption. Strategies. Legislation, 4) International cooperation in combating organized crime and corruption.
