Learning outcomes of the course unit: presenting the basic knowledge of the course General Theory of Law aims to introduce the fundamental legal concepts and categories used in the whole the legal science and practice. Learning about the nature and importance of these legal phenomena is of great importance for further studies of the matter in other legal courses and introduction to specialized books.
- 10. Mode of delivery: face-to-face.
- 11. Prerequisites and co-requisites: Students should have received good preliminary training in Bulgarian language and grammar during their secondary education. A parallel study of Latin Language, Roman Law, History of the Bulgarian State and Law, Logic and Constitutional Law help students to learn faster and more successfully the complex and abstract nature of the legal matter of the course.
- 12. Course contents: The course is conditionally divided into two parts:

The first part focuses on the General Theory of Law as a science, its object, functions and place in the system of legal sciences, the emergence and nature of law, the interaction of law with other social regulators, the basic legal systems, etc. The second part introduces students to the most important legal concepts and structures – legal entity, legal norm, legal relation, subjective law presumptions and fictions, legal acts, legal liability as well as the legal creativity process and law enforcement process in law.
