Learning outcomes of the course unit: Acquisition of **knowledge** about: cultural and historical heritage in the context of its quality as a national value and a subject to special protection by the state; dangers and threats of different nature, measures to protect cultural heritage, etc. Acquisition of **skills**: selection, evaluation and use of available information to solve specific tasks concerning the protection of a specific cultural and historical site; selection and application of tools for risk assessment of the danger of a different character for a particular cultural and historical site, etc. Development of **abilities**: conceptual thinking in the field of protection of cultural heritage; management of activities in the protection of cultural heritage sites, etc. Acquisition of **expertise** in the field of heritage protection, including the acquired knowledge, developed skills, advanced skills, personal attitudes, attitudes and value orientations, providing effective behaviour and actions.

11. Prerequisites and co-requisites: Students should have completed basic public and legal courses and specialized courses in the field of protection of national security and public order.

Course contents: The course presents to students the concept of cultural and historical heritage and its derivatives in the quality of a national value and a subject to special protection by the state. Students acquire knowledge of the dangers and threats to objects of movable and immovable cultural heritage of different nature, legal regulations for protection measures based on an integrated approach and modern risk-technologies.
